BOARDING CONSENT AND WAIVER



- 1. Owner authorizes K9 Kiddos to take all necessary actions, at the sole discretion of K9K staff and management, to maintain the health and well-being of my pet(s), and furthermore agree to be responsible for any and all expenses relating to the same, including all ancillary services requested.
- 2. Owner understands that K9K has relied upon their representation that their dog is in good health at the time of check in for services at our facility. Any pre-existing health concerns or known allergies will be disclosed and discussed prior to check in. All dogs must be flea/tick free. Should a dog be observed to have fleas or ticks, a flea/tick bath treatment will be applied and charged to the owner. Furthermore, owner understands that we do not have a licensed veterinarian on site and may not be able to detect or diagnose a medical condition in your pet.
- 3. Owner specifically represents to K9K that to their knowledge their pet has not been exposed to any contagious diseases within a thirty-day period prior to check in for boarding or any services at our facility. Owner further agrees to provide proof of, and maintain required current vaccinations (DHLPP, Rabies Bordetella) for their pet(s). Owner agrees to allow 12 days waiting period after their dog as had their vaccinations to allow the vaccines to reach full protection potential and to ensure their dog has not has any negative reaction to the vaccines. Owner understands that while their dog is fully vaccinated that vaccines are not guaranteed and there is a small risk that their dog may contract a contagious disease or illness. Owner agrees that should this occur Owner is responsible for their own pet's care and medical attention.
- 4. Owner understands that if their pet becomes ill or injured, or if the state of the pet's health otherwise requires professional attention, K9K, in a non-emergency situation will attempt to contact and inform the owner prior to seeking medical attention. If no contact can be made, or in an emergency situation, K9K at its sole discretion, may enlist the services of a licensed veterinarian for treatment and thereafter attempt contact with owner. Furthermore, all expenses incurred from this treatment will be the sole responsibility of the owner. Owner further understands and agrees that K9K nor any of its employees will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases K9K staff of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending K9 Kiddos.
- 5. Owners of elderly dogs (approaching the end of life) need to know if in the event Owner's dog passes on while in our care, our policy is to transport Owner's dog to Owner's vet where he/she will be held until Owner can be reached by the Vet for further instructions. If Owner's vet is closed, then we will transport to nearest 24-hour facility.
- 6. K9 Kiddos and its employees shall exercise reasonable care for pets under our supervision. If group play is provided, owner recognizes and accepts the potential risks involved in such an activity. Owner further agrees to be solely and financially responsible for any and all of their pet's behavior while it is in our care. This includes but is not limited to damages or injury to the pet itself, other pets, a staff member or any damages to the facility caused by the pet, unless incurred as a direct result of gross negligence on the part of K9K or its staff members.
- 7. Owner understands that K9K is not responsible for loss, damage, or destruction of any items left with your pet.

- 8. Owner agrees that it is the Owner's responsibility to leave adequate supply of food (in pre-portioned bags) and medications for Owner's dog(s) during the entire time Owner's dog is cared for by K9 Kiddos.
- 9. Owner understands that by allowing their dog to participate in services offered by K9K, they hereby agree to allow K9K to take photographs or use images of their pet in print or otherwise for publication, promotion, or social media.
- 10. K9 Kiddos reserves the right to refuse admittance to any dog and/or dismiss any dog that does not meet or maintain the health, temperament or other boarding standards. This determination shall be made at the sole discretion of K9 Kiddos.
- 11. Owner understands that if their pet is not picked up on or before the scheduled check out date, they hereby authorize K9K to take whatever action is deemed necessary for continued care of their dog. Owner will be responsible for the cost of any such continuing care upon demand by K9K and understands that if they do not pick up their pet, K9K will proceed after 5 days of no communication or payment with arrangement according to the guidelines provided by the Abandonment of animals by owner; procedure for handling. Owner also acknowledges that they will be fully responsible for all attorney's fees and associated costs if they abandon their pet.
- 12. Owner agrees that if Owner's dog(s) is/are not picked up by closing time, then Owner hereby authorizes overnight boarding appropriate for dog(s) and will be financially responsible for applicable overnight boarding charge plus any charge for required food.
- 13. Owner further understands and expressly agrees that each and every of the foregoing provisions contained above shall be in force and effect and shall apply to each and every occasion on which Owner's dog(s) stays with K9 Kiddos for boarding or other services, as the case may be. This Agreement shall remain in full force and effect as between the parties unless otherwise cancelled or superseded by a writing signed by the parties.

Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
